### I. INTRODUCTION

This report is developed based on the Consultation Plan for relevant stakeholders in the framework of the development and adoption of an Open Access policy in Angola (Sub-objective 2.2). The report that is presented aims to show a synthesis of the consultation activities with relevant stakeholders carried out between June and December 2021 by the Consultative Committee of the project "Acesso Aberto Angola" constituted by the United Nations Educational, Scientific and Cultural Organization (UNESCO), the Ministério do Ensino Superior, Ciência, Tecnologia e Inovação (MESCTI) of the Government of Angola, the Sistema de Información Científica Redalyc de la Universidad Autónoma del Estado de México (UAEM) [Scientific Information System Redalyc of the Autonomous University of the State of Mexico (UAEM)], AmeliCA and the Universidade Óscar Ribas (UOR) [Óscar Ribas University (UOR)].

In a timely manner, a synthesis of the activities -carried out in three main areas of action- is presented:

- Activities in the Angolan context: activities with relevant stakeholders in the scientific-academic, social and political context of Angola such as government bodies, higher education institutions, universities and other initiatives organized in the scientific-academic, political and social context of Angola.
- Linkage activities with global Open Access initiatives: activities with stakeholders from geographic contexts that have an impact on the field of Open Access from a global perspective; such as promoters of open scientific communication typical of the academic field, civil organizations

and efforts organized by academics and researchers from Latin America, Europe, the United States and Africa.

- 3. Internal and follow-up activities of the Advisory Committee: during the period between June and December 2021, the Advisory Committee held continuous meetings for the evaluation, diagnosis and feedback of the processes carried out by the working groups of each entity involved in the project "Acesso Aberto Angola".
  - The realization of the aforementioned activities gave rise to identifying the perspectives of different stakeholders related to the culture of Open Access in Angola, as well as the feedback of the perspectives of the stakeholders with a global impact. In total, at least 26 activities were carried out, with the inclusion of more than 50 organizations, institutions, scientific-academic communities, and governmental, academic and social entities.

#### **II. ACTIVITIES IN THE ANGOLAN CONTEXT**

Meeting held on June 24th, 2021 between the Universidade Óscar Ribas (UOR) [Oscar Ribas University (UOR)] and the Ministry of Science, Technology and Innovation (MESCTI): 1) the draft of the Office for the assembling of the Technical Group for the creation of a Network of Angolan Scientific Journals and promote Open Access to scientific information; 2) the need to present a budget to ensure the sustainability of the project in the different stages and the elaboration of a work schedule was minded; 3) the actions for the launch of the initiative were proposed at the "7a Conferência sobre Ciência, Tecnologia e Inovação (7th Conference on Science, Technology and Innovation)".

- Virtual meeting held on July 14th, 2021 between the teams of Angola and Mexico for the presentation of the project, in which both stakeholders from Angolan Higher Education Institutions and representatives of AmeliCA, of the Sistema de Información Científica Redalyc de la Universidad Autónoma del Estado de México (UAEM) Scientific Information System Redalyc of the Autonomous University of the State of Mexico (UAEM)], of UNESCO, and of the Universidade Oscar Ribas [Oscar Ribas University] participated.
- Meeting held on August 20th, 2021 between the Universidade Oscar Ribas (UOR) [Oscar Ribas University (UOR)] and the members of the "Acesso Aberto Angola" project team: 1) the general objective was presented, referring to identifying not only the perception and needs of the Government of the Republic of Angola, but its academic authorities, professors and students around Open Access, the scientific production and the academic publication.
- Virtual focus group held on September 2th, 2021 aimed at the academic authorities in Angola, where stakeholders from 6 institutions participated.
- Virtual focus group held on September 16th, 2021 aimed at professor-researchers; 6 stakeholders participated.
- Virtual focus group held on October 27th, 2021 aimed at students; stakeholders from 3 Higher Education Institutions (HEI) in Angola participated.
- Virtual focus group held on November 3th, 2021 aimed at government authorities; stakeholders from 10 institutions participated.




Illustration 7 Angola Open Data Portal, September 27th, 2021





Illustration 13 Meeting held on June 22th, 2021




Illustration 14 Meeting held on July 07th, 2021




Illustration 16 Meeting held on August 11th, 2021




Illustration 17 Meeting held on August 18th, 2021

 Virtual meeting held on October 20, 2021 in which ongoing activities were followed up and the organization to start different tasks of the ongoing project was established.





### **V. RECOMMENDATIONS**

Through the articulated work between the United Nations Educational, Scientific and Cultural Organization (UNESCO), the Ministério do Ensino Superior, Ciência, Tecnologia e Inovação (MESCTI) of the Government of Angola, the Sistema de Información Científica Redalyc de la Universidad Autónoma del Estado de México (UAEM) [Scientific Information System Redalyc of the Autonomous University of the State of Mexico (UAEM)], and the Universidade Óscar Ribas (UOR) [Óscar Ribas University (UOR)] that took place in the period between June and December of 2021, it was possible to identify areas of opportunity for the strengthening of the project in question. within the framework of development and adoption of an Open Access policy in Angola:

 Establish links with stakeholders from Higher Education Institutions (HEI), universities and other organized initiatives, as well as with government authorities and organized initiatives for Open Access and Open Science in other African countries.

- 2. Strengthen the established link with the academic-scientific and student community of Higher Education Institutions (HEI) and Angolan universities.
- 3. Give continuity to the dialogue and joint work of the Consultative Committee of the "Acesso Aberto Angola" project with the authorities of the Ministério do Ensino Superior, Ciência, Tecnologia e Inovação [(MESCTI) Ministry of Higher Education, Science, Technology and Innovation] of the Government of Angola and the diversity of relevant stakeholders in the development and adoption of an Open Access policy in Angola.
